- i) If eligible women candidates are not available for selection, their vacancy will be filled up by the men candidates of the same community in every stage of the recruitment.
- ii) No other reservation such as Department quota, Sports quota, Wards cum Dependent quota and PSTM preference are applicable for this shortfall vacancies.
- **4) SCALE OF PAY:** Rs. 36,900 1,16,600/-

5) EDUCATIONAL QUALIFICATION:

- **I.** Candidates should have a Bachelor's Degree from any University recognized by UGC / Government on or before the date of Notification.
- II. The Bachelor's Degree should have been obtained in the following patterns:
 - a) After completion of SSLC and Higher Secondary course in the order of 10+2+3 / 4 / 5 pattern

or

b) After completion of SSLC and Diploma in the order of 10+3+2 / 10+3+3 pattern

or

- c) After completion of SSLC and 2 years ITI in the order of 10+2+3 pattern.
- III. A Bachelor's Degree can be obtained from Open University / Distance Education / College. However, candidates who have obtained Bachelor's Degree through Open Universities directly without going through above mentioned patterns will not be eligible.
- **Note:** Candidates who have passed 10th standard directly without studying 9th standard or passed 12th standard directly without studying 11th standard are not eligible.

6) AGE:

The Candidates must have completed the age of 20 years and must not have completed the age of 30 years as on **01.07.2025** (must have born on or after 02.07.1995 and on or before 01.07.2005). The upper age limit relaxation given to certain categories are as follows:

7) COMMUNAL RESERVATION:

a) The existing Government rules / orders pertaining to communal reservation followed by the Board are as under: -

Backward Class (BC)	26.5%
Backward Class (Muslim) [BC(M)]	3.5%
Most Backward Class / Denotified Communities (MBC/DNC)	20%
Scheduled Caste (SC)	15%
Scheduled Caste (Arunthathiyar) [SC(A)]	3%
Scheduled Tribe (ST)	1%

Note: i) The number of posts allotted to each category will be as per the 200 point roster stipulated in Schedule – V of Tamil Nadu Government Servants (Conditions of Service) Act, 2016.

ii) As per G.O.(Ms) No.38, Adi Dravidar and Tribal Welfare (CV-1) Department, Dt: 17.03.2023 the community "Narikoravan, Kurivikkaran" has been incorporated in ST Community list from MBC Community list.

- b) Community certificate issued by the competent authority of Government of Tamil Nadu alone will be considered for communal reservation.
- c) In every stage of recruitment, if excess number of SC (Arunthathiyar) eligible candidates are available after filling up of SC (Arunthathiyar) vacancies they will be selected under Scheduled Caste reservation, if no eligible candidates are available for filling up the Scheduled Caste (Arunthathiyar) vacancies, these vacancies will be filled by eligible Scheduled Caste candidates.

- I. Departmental Quota 20% from overall vacancy.
- II. Wards cum Dependent Quota 10% of the remaining 80%.
 - a. Executive Wards Quota 9%
 - b. Ministerial Wards Quota 1%
- III. Sports Quota 10% of the remaining 80%.
 - a. Sports Quota 7%
 - b. Meritorious Sports Persons Quota 3% To be filled through SDAT

9) ELIGIBILITY FOR APPLYING UNDER 10% WARDS CUM DEPENDENT QUOTA:

- i. Wards cum dependent of Serving / Retired / Deceased or Medically invalidated Police Personnel (Executive) and Ministerial Staff of Police Department.
- ii. Wards cum dependent of personnel removed from Service / Dismissed from service are not eligible to apply for this Wards cum Dependent Quota.
- iii. Son, Legally Adopted Son, Unmarried Daughter and Legally Adopted Unmarried Daughter are eligible for this Wards cum Dependent Quota.

- iv. Married women candidates are not eligible to claim Wards cum Dependent Quota.
- v. Wards cum dependent certificate should be obtained from the competent authority not below the rank of Superintendent of Police in the prescribed format specified in the <u>Annexure. II & II (A).</u>
- vi. Wards cum dependent certificate should be obtained after the date of notification and on or before the last date of online application.
- vii. If the Wards cum dependent certificate is not obtained in the prescribed format, then the candidate will be treated as a General Candidate.
- viii. Only one ward of the Police Personnel / Ministerial Staff shall apply under the Wards cum Dependent Quota.
- ix. Candidates already serving under Central / State Government / Public Sector Undertaking (PSU) are not eligible to apply the Wards cum Dependent Quota.
- x. In case required number of candidates are not available for the Wards cum Dependent Quota, the vacancies would be transferred to open quota of the same community.
- xi. Communal reservation and PSTM preference are provided within Wards cum Dependent Quota as per existing rules.
- xii. If a candidate claims the Wards Cum Dependent Quota, he / she cannot claim the Sports Quota even though he / she possesses the sports certificates (Form-I / Form II / Form III).
- xiii. The candidate who claims Wards Cum Dependent Quota can avail the special marks for Sports Certificates if he / she possesses the relevant Sports certificates.
- xiv. If a Police Personnel / Ministerial Staff who has already availed benefit under this Quota to one of their Wards, he / she cannot avail this benefit again under this Quota to another ward.

10) ELIGIBILITY FOR APPLYING UNDER 7% SPORTS QUOTA:

i. Candidates applying under Sports Quota should fulfill all the norms prescribed for Open Candidates. In addition, the candidate is required to produce Form - I or Form - II or Form - III of any one of the approved 16 games / sports for an event held within 5 years preceding the date of notification i.e., from 03.04.2020 to 01.04.2025.

ii. The details of certificates required for claiming Sports Quota are as follows: -

iii. List of approved Games and Sports

- 1.Basketball, 2. Football, 3. Hockey, 4. Volleyball, 5. Handball, 6. Kabbadi, 7. Wrestling,
- 8. Boxing, 9. Gymnastics, 10. Judo, 11. Weightlifting, 12. Aquatics (Swimming), 13. Athletics,
- 14. Equitation (Horse riding), 15. Rifle Shooting and 16. Silambam*.

- iv. The candidate should have participated in the events representing India / State of Tamil Nadu and obtained the Form I or Form II certificates from the recognized associations of Indian Olympic Association / Sports Development Authority of Tamil Nadu or Tamil Nadu Olympic Association. The list of recognised Sports Associations is furnished in Annexure IX. The Form I & Form II certificates obtained from any other Associations are not eligible for availing Sports Quota.
- v. The candidates should have participated in the events representing the Tamil Nadu Universities and obtained the Form III certificate from the Director or other Officer in-Charge of Sports in the University.
- vi. The Sports Quota candidate will have to participate in the Written Examination (Part I and Part II), Certificate Verification, Physical Measurement Test, Endurance Test, Physical Efficiency Tests and Viva-Voce similar to Open Candidates.
- vii. In case of required number of candidates are not available in the Sports Quota, the vacancies would be transferred to Open Category of the same community.
- viii. Communal reservation and PSTM preference are followed within Sports Quota as per existing rules.
 - ix. In Form I / Form II / Form III Sports Certificates, Name of the Participant, Name of the Game, Date of Event and Name and Seal of the Certificate Issuing Authority are mandatory, otherwise these candidates will be treated as Open candidates.

11) 3% Sports quota for the Meritorious Sports Persons

Guidelines and Modalities regarding appointment of Meritorious Sports Persons under 3% reservation through Sports Development Authority of Tamil Nadu as per G.O.(Ms).No.116, Home (Police.3) Department. Dated: 07.03.2025.

- i. Maximum Age limit 35 Years
- ii. Educational Qualification As per the existing norms for open candidates.
- iii. Eligible sports for consideration under sports quota As per the norms in G.O.(Ms). No. 6, Youth Welfare and Sports Development (S1) Department, dated 20.02.2019 as amended from time to time.
- iv. The above said Government orders are given in Annexure XII.
- v. PMT, ET and PET As per the existing norms for open candidates.
- vi. The Meritorious Sports Persons are exempted from the Written Examination and Viva Voce.
- vii. Allotment of Category (TALUK and AR) The allotment will be based on the marks allotted by the Sports Development Authority of Tamil Nadu, based on their option without following the communal rotation.
- viii. Medical Examination and Verification of Character & Antecedent As per the existing norms for open candidates.
- ix. If sufficient number of candidates are not available in 3% Sports Quota, the remaining vacancies shall be filled up along with 7% Sports Quota by following regular recruitment procedures as applicable to the said post. In spite of this if candidates are not available for 7% vacancies, it shall be filled up from General Pool as per G.O.(Ms).No.960, Home (Police 3) Department, Dated 18.12.2014.
- x. For Meritorious Sports Candidates the online application portal is available in SDAT official website page only: https://sdat.tn.gov.in/. Screenshot of the webpage is given in Annexure-XIII.
- xi. The last date for submission of online application for Meritorious Sports Candidates will be available in SDAT website.
- xii. The instructions contained in the website of the SDAT may be followed with regard to further recruitment process.

12) PSTM PREFERENCE (20%):

- i. At every stage of selection, 20% of all the vacancies shall be set apart on preferential basis for the Open Candidates, Sports Quota Candidates and Wards cum Dependent Quota Candidates who have studied in Tamil Medium. To claim this preference the entire education of the candidate should be essentially in Tamil Medium for all the classes from 1st standard to Bachelor's Degree. PSTM preference is not applicable to Departmental Quota candidates. (Certificate model Annexure III & III (A)).
- ii. "Person Studied in Tamil Medium" (PSTM) means a person who has studied through Tamil Medium of instruction up to the educational qualification prescribed for Direct Recruitment in the rules or regulations or orders

- applicable to any appointment in the services under the State.
- iii. As evidence for 'Person Studied in Tamil Medium', a certificate from the Principal / Head Master / District Educational Officer / Chief Educational Officer / District Adi Dravida Welfare Officer / Registrar / Controller of Examinations / Head / Director of the Educational Institution / Director / Joint Director of Technical Education / Registrar of Universities as the case may be, in the format as in **Annexure-III & III (A)**, must be uploaded for each and every class i.e. from 1st standard to Bachelor's Degree.
- iv. Failure to upload such documents as evidence for 'Person Studied in Tamil Medium' for the classes studied up to the prescribed educational qualification, will not be considered for PSTM preference.
- v. Documents uploaded as proof of having studied in Tamil Medium, for the partial duration of any course / private appearance at any examination, will not be considered for PSTM preference.

13) CONCESSIONS FOR SPECIAL CATEGORIES:

A. EX-SERVICEMEN / SERVING MILITARY PERSONNEL WHO ARE GOING TO RETIRE WITHIN ONE YEAR FROM THE LAST DATE OF RECEIPT OF THE APPLICATION / EX-PERSONNEL OF CENTRAL ARMED POLICE FORCES: -

- i. The Ex-Servicemen / Ex-Personnel of Central Armed Police Forces who have not completed 3 years after discharge from service as on date of notification are only eligible to apply for this recruitment.
- ii. The discharge certificate should be uploaded in the online application. The document uploaded without mentioning the name and date of discharge will not be considered for age relaxation.
- iii. If the Ex-servicemen / Ex-personnel of CAPF fail to upload their discharge certificate, their application will not be considered under the respective category.
- iv. The Ex-servicemen / Ex-personnel of CAPF once get appointed to any government post then he / she cannot claim the relaxation again under the Ex-servicemen category.
- v. The serving personnel of Armed Forces who are going to retire within one year from the last date of receipt of online application should upload a certificate specifying the Name and date to be discharged, obtained from the Commanding Officer of his / her unit in the prescribed format. Failing which they will not be considered for age relaxation. (Specimen Undertaking certificate is available in **Annexure IV**).
- vi. Ex-servicewomen will be treated in line with Ex-servicemen.

B. DESTITUTE WIDOW:

- i. The Destitute Widow candidates should obtain "Destitute Widow Certificate" from the Revenue Divisional Officer / Sub-Collector / Assistant Collector and upload the same along with the online application, failing which they will not be considered under Destitute Widow category. Certificates obtained from any other authority such as Tahsildar, Zonal Tahsildar etc., will not be accepted. (Specimen certificate is available in Annexure.V).
- ii. Candidate who uploads Widow Certificate or Divorcee Certificate will not be considered as Destitute Widow.
- iii. Claim as Destitute Widow shall be admitted only if the date of demise of husband is on or before the date of notification.
- iv. Any correction in the Destitute Widow certificate must be attested by the issuing authority or a fresh certificate in lieu thereof must be uploaded.

14) TRANSGENDER:

- i. The Transgender candidates may decide their own gender as men or women for recruitment purpose. Transgender candidate should upload an Identity Card obtained from the Tamil Nadu Transgender Welfare Board / District Collector. (Specimen Identity Card is available in <u>Annexure.VI</u>).
- ii. If the Transgender ID card, issued by any authority other than the Tamil Nadu Transgender Welfare Board or District Collector is uploaded then after due process the candidate will be considered under Open category of his / her community.
- iii. A Transgender candidate who chooses to appear as male should participate in the Certificate Verification, Physical Measurement Test, Endurance Test, Physical Efficiency Test and Viva-Voce along with male candidates. A Transgender candidate who chooses to appear as female should participate in the Certificate Verification, Physical Measurement Test, Endurance Test, Physical Efficiency Test and Viva-Voce along with female candidates. Once the gender is selected either as male or female, it cannot be changed afterwards in the later stages of recruitment.
- iv. A Transgender candidate who chooses to appear as female will be treated as female candidate and will be eligible for reservation applicable to female candidates. A transgender candidate who chooses to appear as male will be treated as male candidate and will be eligible for reservation applicable to male candidates.
- v. The Transgender candidates shall be granted age relaxation similar to the age relaxation provided to the Scheduled Caste and Scheduled Tribe Candidates.

- vi. The transgender candidates who do not produce their community certificate will be treated as MBC category for purposes other than the age relaxation criteria.
- vii. Transgender candidates who belong to Scheduled Caste / Scheduled Caste (Arunthathiyar) / Scheduled Tribe communities and possess community certificate as such, shall be considered as per their respective community.
- viii. Transgender candidates who belong to communities other than Scheduled Caste / Scheduled Caste (Arunthathiyar) / Scheduled Tribe and possess community certificate as such, are permitted to choose to be considered as belonging to their own community or as Most Backward Class, whichever is advantageous to them, at the time of submission of Online Application itself.
- ix. Once the individual opts to be considered as a particular community, it shall be crystallized and this option cannot be changed in the future.
- x. Transgender candidates who do not possess a community certificate and have chosen to be considered under 'Most Backward Classes' and those in possession of a community certificate as Backward Classes / Backward Classes (Muslim) / Denotified Communities but have chosen to be considered under 'Most Backward Classes' need not upload a community certificate in support of their claim.

16) STAGES OF RECRUITMENT FOR OPEN CANDIDATES:

A. WRITTEN EXAMINATION:

Part-I. Tamil Language Eligibility Test:

- i. Tamil Language Eligibility Test is qualifying in nature.
- ii. It will be objective in nature.
- iii. It will consist of 100 questions for 100 marks and the duration of examination will be 100 minutes (1 Hour 40 minutes.)
- iv. The candidate has to obtain **minimum 40 marks (40%)** in Tamil Language Eligibility Test, for him / her to be eligible for evaluation of their Main Written Examination OMR Answer Sheet.
- v. The marks obtained in Tamil Language Eligibility Test will not be considered for preparation of provisional selection list at any stage.
- vi. In respect of 20% Departmental candidates, the Tamil Language Eligibility Test will be commonly conducted along with those who are applying under open quota. The candidates who have applied under "BOTH" Open and Departmental category will have to write the commonly conducted Tamil Language Eligibility Test only once.

Part-II. Main Written Examination:

The Main written examination consists of **Part-A** - General Knowledge **Part-B** - Logical Analysis, Numerical Analysis, Psychology Test, Communication Skills and Information Handling Ability.

Main Written Examination total marks are 70.

- i. Part-A 40 Marks consisting of 80 Questions (objective type).
- ii. Part-B 30 Marks consisting of 60 Questions (objective type).
- iii. Each question carries ½ mark.
- iv. Duration 2 ½ hours.
- v. The candidates should get **minimum 25 marks (35%) to** qualify in the Main Written Examination.
- vi. Out of those who qualify in the Main Written Examination, only five times the number of notified vacancies will be called for next stage of selection i.e., Certificate Verification, PMT, ET & PET in each category based on the merit and communal reservation. However, all the candidates who secure the same marks as that of cut-off marks of their respective category shall also be admitted to CV, PMT, ET & PET as additional candidates. Hence the number of candidates called for CV, PMT, ET & PET may exceed the 1:5 ratio.

- vii. Hall Ticket for Written Examination: The Hall Tickets of the eligible candidates will be uploaded on the TNUSRB official website (www.tnusrb.tn.gov.in) before commencement of the Written Examination. The candidate can login his / her account with User ID and Password to download and take a colour print of the Hall Ticket for attending the Written Examination.
- viii. After publication of Written Examination Preliminary Answer Key, the candidates may represent any discrepancy in the Questions or Answers with appropriate proof, with details like 1. Name of the Candidate, 2. Enrolment Number. 3. Question Series and Question Number within seven working days by Tapal addressed to "The IGP / Member Secretary, Tamil Nadu Uniformed Services Recruitment Board, Old COP office campus, Pantheon Road, Egmore, Chennai 600 008" or e-mail to usrb91@gmail.com Any representation received after seven working days will not be accepted.

B. PHYSICAL EXAMINATION:

I. CERTIFICATE VERIFICATION:

- i. The certificate verification will be carried out before the Physical Measurement Test, Endurance Test and Physical Efficiency Test for Open Candidates at the respective centres.
- ii. The candidates who are called for Certificate Verification will have to produce all the relevant Original Certificates and its two Photocopies which were uploaded during submission of Online Application. Any other certificate submitted during Certificate Verification will not be considered.
- iii. Certificates submitted by candidates after the process of Original Certificate Verification at the centre will be summarily rejected.
- iv. Candidate who fails to produce the Original Certificates will lose his / her claims with regard to Educational Qualification, Communal Reservation, Age Relaxation, Preference, Special Quota, Special Marks, etc.,

II. PHYSICAL MEASUREMENT TEST:

i. The norms for Open Candidates for Physical Measurement Test are as follows:

ii. **Rounding off of Height and Chest Measurements**: All the Physical Measurements (Height / Chest) will be rounded off to the nearest 0.5 cm to take care of margin of error as per the formula given below:

The same procedure shall be followed in Chest measurement. The same procedure shall also be followed for women candidates during height measurement.

- iii. **Appeal in Physical Measurement Test:** When a candidate is not satisfied with his / her measurement, he / she can prefer an appeal to the Sub-Committee Chairperson regarding height / chest re-measurement.
- iv. Physical Measurement Test is qualifying in nature.
- v. There is no Physical Measurement Test for Ex-servicemen, serving Military personnel who are going to retire within one year and Ex-CAPF.

- vi. The candidates who qualify in the Physical Measurement Test will be allowed to participate in the Endurance Test.
- vii. The Height / Chest measurement certificate given by Government hospitals or any other agency will not be considered.

III. ENDURANCE TEST

(i) The norms for open candidates for Endurance Test are as follows: -

Men	1500 metres run in 7 minutes or less
Women	400 metres run in 2 minutes 30 seconds or less.
Ex-servicemen / Serving Military Personnel who are going to retire within one year / Ex-personnel of Central Armed Police Forces.	1500 metres run in 8 minutes or less.

- (ii) Endurance Test is qualifying in nature.
- (iii) Only the candidates who qualify in the Endurance Test will be allowed to participate in the Physical Efficiency Test.
- (iv) No excuses will be entertained with regard to ill health or any other injuries at the centre.
- **IV. PHYSICAL EFFICIENCY TEST:** Total mark for PET is 15. The details of Physical Efficiency Tests are as follows:

17) ELIGIBILITY FOR 20% POLICE DEPARTMENTAL QUOTA CANDIDATES:

- i. Gr.II Police Constables / Gr.I Police Constables / Head Constables serving in Taluk Police, Armed Reserve Police and their equivalent ranks serving in the Tamil Nadu Special Police can apply under 20% Departmental Quota if they meet the following eligibility criteria under Rule -14 of TNPSS Rules,1953 and TNSPSS Rules 1978.
 - a. They should have completed 5 years of service as on **01-07-2024**.
 - b. They should have a clean record without any punishment other than the minor punishments of black mark, reprimand and censure in their entire service.
 - c. The Departmental Candidates should obtain NOC in the prescribed format from the Head of Unit / Office / Competent Authority and the same should be uploaded while applying Online application (Specimen NOC is available in Annexure.VII).

- ii. Main Written Examination for Departmental Quota will be held separately. A Departmental Candidate may apply for both Open and Departmental Quota as a single application, if he / she satisfies the eligibility criteria.
- iii. In case required number of candidates are not available in the Departmental Quota, the vacancies will be filled up with Open Quota candidates of the same community.
- iv. Communal Reservation is followed within Departmental Quota as per existing rules.
- v. 20% PSTM preference is not applicable for Departmental Candidates.

18) STAGES OF RECRUITMENT FOR 20% DEPARTMENTAL CANDIDATES:

A. WRITTEN EXAMINATION:

Part I. TAMIL LANGUAGE ELIGIBILITY TEST:

The norms for conducting Tamil Language Eligibility Test for Departmental candidates will be the same as conducted for Open candidates.

Part II. MAIN WRITTEN EXAMINATION FOR DEPARTMENTAL QUOTA (20%):

Main written examination consists of **Part-A** - General Knowledge **Part-B** - Communication Skills, Numerical Skills, Logical Analysis and Information Handling Ability. Bharatiya Nyaya Sanhita (BNS), Bharatiya Nagarik Suraksha Sanhita (BNSS), Bharatiya Sakshya Adhiniyam (BSA), Police Standing Orders and Police Administration.

Main Written Examination Total Marks are 85.

Part - A: 15 Marks consists of 30 Questions (Objective Type).

Part - B: 70 Marks consists of 140 Questions (Objective Type).

- i. Each question carries ½ mark.
- ii. Duration of the examination 3.00 hrs.
- iii. The candidates should get a **minimum of 30 marks (35%)** to qualify in the Written Examination.
- iv. Out of those who qualify in the Written Examination, the number of candidates called for the Certificate Verification and Endurance Test will be 5 times the number of notified vacancies based on the merit and communal reservation. However, all the candidates who secure the same marks as that of cut-off marks of their respective category shall also be admitted to Certificate Verification and Endurance Test as additional candidates. Hence the number of candidates called for CV & ET may exceed the **1:5** ratio.

- v. Hall Ticket for Written examination: The hall tickets of the candidates will be uploaded on the TNUSRB official website (www.tnusrb.tn.gov.in) before commencement of the Written Examination. The candidate can login to his / her account with User ID and Password to download and take a Colour Print of the Hall Ticket for attending the Written Examination.
- vi. After publication of Written Examination Preliminary Answer Key, the candidates may represent any discrepancy in the Questions or Answers with appropriate proof, with details like 1. Name of the Candidate, 2. Enrolment Number. 3. Question Series and Question Number within 7 working days by Tapal addressed to "The IGP / Member Secretary, Tamil Nadu Uniformed Services Recruitment Board, Old COP office campus, Pantheon Road, Egmore, Chennai 600 008" or e-mail to usrb91@gmail.com Any representation received after 7 working days will not be accepted.

B. CERTIFICATE VERIFICATION FOR DEPARTMENTAL QUOTA:

- i. The Certificate Verification will be carried out before the Endurance Test for Departmental candidates.
- ii. The Departmental candidates who were called for Certificate Verification will have to produce all the relevant Original Certificates and its two Photocopies which were uploaded during submission of Online Application. Any other certificate submitted during certificate verification will not be considered.
- iii. Certificates submitted by Departmental Candidates after the process of Original Certificate Verification at the centre will be summarily rejected.
- iv. The Departmental candidates who were called for Certificate Verification will have to produce their **Original Certificates**. Departmental Candidate who fails to produce the Original Certificates will lose his / her claims with regard to Educational Qualification, Communal Reservation and Special Marks.

C. PHYSICAL MEASUREMENT TEST & PHYSICAL EFFICIENCY TEST:

Departmental Quota candidates are exempted from Physical Measurement Test and Physical Efficiency Test.

D. ENDURANCE TEST: 1500 metres run in 7 minutes for men candidates and 400 metres run in 2 minutes and 30 seconds for women candidates. This test is qualifying in nature.

19) PREGNANT WOMEN (OPEN AND DEPARTMENTAL) CANDIDATES:

- Pregnant women candidates should mention the pregnancy status during submission of online application.
- ii. During the Physical Test, the pregnant woman candidate should inform the Chairperson of the sub-committee of the centre about her pregnancy status.
- iii. The pregnant women candidates declared unfit by the government doctor are temporarily excluded from the selection process and further next process of selection proposed to be conducted once in every six months, say February 1st week and August 1st week for such candidates.
- iv. A pregnant woman candidate will not lose her batch seniority for not participating in Physical Test in view of her pregnancy (i.e.) if a pregnant woman is selected on the basis of the Physical Test in the next process of selection her batch seniority should be determined with reference to the recruitment in which she cleared the Written Examination.
- v. Pregnant candidates who would like to participate in the Endurance Test and Physical Efficiency Test should submit fitness certificate from a Government Doctor and Self Declaration / Undertaking Letter by the candidate. The Pregnant candidates should not claim any additional benefits during the Physical Test events.

20) VIVA-VOCE: (OPEN AND DEPARTMENTAL)

- i. Viva-Voce will be conducted for 10 marks. Marks will be awarded based on the performance of the candidate in Viva-Voce.
- ii. The Open Candidates who qualify in Certificate Verification, Physical Measurement Test, Endurance Test and who participated in all the events of the Physical Efficiency Test will be eligible for Viva-Voce. However, the number of candidates called for Viva-Voce will be 2 times the number of notified vacancies only. Besides, the candidates with same scores with respect to cut-off mark will also be called under each category as additional candidates. Hence the number of candidates called for Viva-Voce may exceed the **1:2** ratio.
- iii. Similarly, the 20% Departmental Candidates who qualify in Certificate Verification and Endurance Test will be eligible for Viva-Voce. However, the number of candidates called for Viva-Voce will be 2 times the number of notified departmental vacancies only. Besides, the candidates with same marks with respect to cut-off mark will also be called under each category as additional candidates. Hence the number of Departmental Candidates called for Viva-Voce may exceed the **1:2** ratio.

- iv. The Viva-Voce will be conducted at TNUSRB Office, Egmore, Chennai-08. Candidates who are called for Viva-Voce should produce all the Original Certificates and its two sets of photocopies at the time of Viva-Voce which were uploaded in the online application.
- v. Candidates who are serving in State Government / Central Government / Public Sector Undertaking (other than the Departmental Quota Candidates) should produce "No Objection Certificate" obtained from their respective Unit Heads as per Annexure-VIII.
- vi. Open Candidates who are possessing NCC / NSS / Sports Certificates or Medals recipients of Departmental Candidates in National Police Duty Meet should produce the Original Certificates and its two sets of photo copies at the time of Viva-Voce for awarding Special Marks.

In each category, only the highest certificate (yielding maximum marks) will be considered. If a candidate is having two certificates which are carrying equal marks, only one certificate will be considered for awarding marks. A candidate can claim maximum of 5 marks under Special Marks. Candidates will be awarded Special Marks for representing Indian Nation / Tamil Nadu State / Tamil Nadu Universities and obtained Form-I / Form-II / Form-III certificates from the recognized associations of Indian Olympic Association / Sports Development Authority of Tamil Nadu / Tamil Nadu Olympic Association / A sports officers of Tamil Nadu Universities. If a candidate is having two medals which are carrying equal marks, only one medal certificate will be considered for awarding marks. The Highest Medal Certificate (yielding maximum marks) will be considered for awarding Special Marks.

Special Marks for Departmental Candidates shall be allotted at the stage of Viva-Voce after perusal of relevant certificates / documents by the concerned authority.

22) FINAL PROVISIONAL SELECTION LIST:

- i. Final Provisional Selection List is drawn based on the total marks obtained by the candidate in the Main Written Examination, Physical Efficiency Test, Viva-Voce and Special Marks subject to communal reservation and notified vacancies.
- ii. If there is a tie in total marks, the candidate senior in age will be given priority in selection.
- iii. If the total marks secured are equal and date of birth is same, preference will be given to the candidate who received an award from His Excellency the President of India.
- iv. If the total marks and date of birth are same and also possessing an award from His Excellency the President of India for outstanding Scout, then the Main Written Exam Marks will be given priority.
- v. If the total marks, date of birth are same and also possessing an award from His Excellency the President of India for outstanding Scout and the Main Written Exam Marks are also same, then online application seniority will be given priority.
- vi. If a candidate applied under both Open and Departmental Quota and was selected in both the Quotas the candidate will be appointed under the Departmental Quota only. Provided if the candidate is allotted Taluk under open category and AR under Departmental category then the candidate will be appointed under open category as Sub Inspector of Police (Taluk).
- vii. The Provisional Selection List will be published on the TNUSRB official website www.tnusrb.tn.gov.in.
- viii. The allotment of category which includes Taluk and Armed Reserve will be done as per the G.O. MS. No. 10, Home (Police III) Department Dated:04.01.2012 detailed below and it cannot be changed later.
 - a) The highest ranking candidates shall be allotted to Taluk subject to rules of reservation for the notified number of vacancies in this category.
 - b) Next level of ranking candidates shall be allotted to Armed Reserve subject to rules of reservation for the notified number of vacancies in this category.

23) MEDICAL EXAMINATION AND VERIFICATION OF CHARACTER AND ANTECEDENTS:

Provisionally selected candidates will have to undergo Medical Examination as per **Annexure - X** and the Character and Antecedents will be verified by the Appointing Authority concerned.

24) ONLINE APPLICATION

- i. Candidates can apply online only through TNUSRB official website www.tnusrb.tn.gov.in Any other mode / form of application will be summarily rejected.
- ii. The candidates should have their own e-mail ID and mobile number while filling the Online application which should be used for the entire application / recruitment process.
- iii. The candidate should furnish his / her jurisdiction Police Station in the online application for Character and Antecedents Verification.
- iv. The candidate should furnish either the name of Father / Mother / Guardian and it is not necessary to fill all the three fields while submitting the Online application.
- v. Hall Tickets / Call letters for eligible candidates at various stages of examinations should be downloaded by the candidates from TNUSRB official website and advised to take colour print. No postal Hall Tickets / Call letters will be issued.
- vi. A Departmental Candidate who is eligible to apply for both Open and Departmental Quota should not submit separate application instead should select the option "**BOTH**" in the column specified in the Online application.
- vii. Image of the Left Thumb Impression of the candidate should be uploaded in the document upload section of the Online application.

25) EXAMINATION FEE:

Open or Departmental Quota Examination fee is Rs.500/-. If a Departmental Candidate applies for both Open Quota and Departmental Quota he / she should pay a sum of Rs.1000/- as Examination fee. It shall be paid only through Online payment.

i. ORDER:-

In the Government Order second read above, among others, orders are issued to recruit maximum of 5 persons every year without going through the testing procedures for outstanding sports achievements and won medals / awards in National / International games.

2. As per orders issued in Government Orders first to third read above, the Tamil Nadu Uniformed Services Recruitment Board, at present, earmarks 10% vacancies to Sports Quota in its Notifications. All the candidates applying under the Sports Quota are subjected to Written Examination, Physical Efficiency Test, Physical Measurement Test and by giving special marks to the achievements and after these procedures, successful candidates are provisionally selected for appointment subject to clearance of Medical Examination and Antecedent verification.

- 3. Subsequently, the Government in Youth Welfare and Sports Development Department have taken a policy decision to provide 3% Horizontal reservation for the meritorious sports persons in identified posts in Government Departments / Public Sector Undertakings as per eligibility. As per this policy, guidelines and modalities were issued in the Government Order fourth read above. In the guidelines, the posts identified for the appointment of meritorious sports persons under 3% sports reservation were classified into 4 categories.
- 4. In the Government Order fifth read above, a Selection Committee headed by the Secretary, Youth Welfare and Sports Development Department with 11 members has been constituted to select the meritorious sports persons for the posts classified under Category-II and Category-III in the guidelines issued in the Government Order fourth read above. The Committee has often met and furnished a list of candidates recommended for appointment under 3% sports quota for Government departments including Police department. Hence, it is considered that framing of Guidelines / Procedures is necessary in appointment of Meritorious Sports persons who won the medals in National/International games/sports to the posts governing under the Tamil Nadu Police/ Special Police Sub-ordinate Services in addition to the procedures already issued in Government Order second read above.
- 5. After detailed discussions, the Director General of Police / Head of Police Force has sent consolidated proposal for appointing 3% quota from the existing 10% Sports quota to fill up with the meritorious sports persons selected by the Selection Committee constituted in the Government Order fifth read above for appointment in Police department as per the Government Order third read above. The Director General of Police / Head of Police Force, Chennai in his proposal has also sent the details pertaining to the existing norms for the candidates under sports category under 7% reservation and the proposed requirement of the sports category candidates under 3% reservation as identified by the Selection Committee referred in the Government Order fourth read above.
- 6. The Director General of Police / Head of Police Force has also informed that if the person(s) already selected under Sports quota/Open quota and working in Police Department and got medal or else participated in National/International games, they will be recognised for their achievements. The Selection Committee of Youth Welfare and Sports Development Department will consider them for higher category posts, if they apply, as per their eligibility.
- 7. The Director General of Police / Head of Police Force, Chennai has therefore requested to consider to issue appropriate orders on the above aspects to facilitate the Tamil Nadu Uniformed Services Recruitment Board to implement the selection of candidates under 3% Sports quota for appointment in Police department as per Government Order fourth read above.

- 8. The Government have carefully examined the proposal of the Director General of Police / Head of Police Force, Chennai with the existing norms and procedures followed in the recruitments conducted by the Tamil Nadu Uniformed Services Recruitment Board and have decided to accept the proposal with slight modifications.
- 9. Accordingly, the Government hereby direct that existing 10% sports quota in Police Department shall be followed as follows:
 - i) 7% sports quota to be continued with the existing recruitment procedures as ordered in Government Order second read above.
 - ii) The remaining 3% sports quota shall be earmarked for the meritorious sports person selected by the Selection Committee as per the procedures laid down in the Government Order fourth and fifth read above.
- 10. The Government also issue the following guidelines to be adopted in the appointment of meritorious sports persons under 3% reservation as identified and recommended by the Sports Development Authority of Tamil Nadu to the posts governing under the Tamil Nadu Police Sub-ordinate Services and Tamil Nadu Special Police Sub-ordinate Services:-

If sufficient number of candidates are not available for 3% Sports quota, the remaining vacancies shall be filled up along with 7% Sports Quota by following regular recruitment procedures as applicable to the said post. Even then, if candidates are not available for 7% vacancies, that shall be filled up from General Pool as per Government Order third read above.
- 12. The Government also order that if the person(s) already selected under Sports quota/Open quota and working in Police Department and got medal or else participated in National/International games, they will be recognised for their achievements. The Selection Committee of Youth Welfare and Sports Development Department will consider them for higher category posts, if they apply, as per their eligibility through the Director General of Police / Head of Police Force.
- 13. The Government also order that the appointment of 5 meritorious sports persons every year who won the medals in National/International games/sports for the post of Grade-II Police Constable/Sub-Inspector of Police as ordered among others in paras 8(vii) and 9 of Government Order second read above shall be discontinued.

14. The Director General of Police / Head of Police Force is directed to send the necessary amendment proposal for amending the Special Rules for Tamil Nadu Police Subordinate Services and the Tamil Nadu Special Police Subordinate Services, immediately.

ORDER:

During the Independence Day speech in the year 2018, the Hon'ble Chief Minister of Tamil Nadu, made an announcement, among other things, that 2% Horizontal reservation would be provided in identified posts in Government Departments/Public Sector Undertakings (PSUs) as per eligibility.

2. In the Government Order second read above, orders have been issued constituting a High Level Committee headed by the Chief Secretary to Government to frame detailed guidelines and modalities for implementation of reservation for meritorious sportspersons in the recruitment for the posts in Government Departments / Public Sector Undertakings (PSUs).

- 3. Subsequently, on 16.10.2018, during the function of awarding of High Cash Incentive to medalists of 63rd National School Games 2017-18 and Felicitation function conducted by the Sports Associations in recognition of the above announcement, the Hon'ble Chief Minister has announced the enhancement of the above reservation from 2% to 3%.
- 4. The meeting of the High Level Committee (HLC) under the Chairpersonship of the Chief Secretary to Government was held on 3.1.2019 to discuss the methodology of implementing the 3% reservation in selected posts in Government Departments / PSUs. The Committee recommended the guidelines and modalities for Sports Achievements Eligible for Quota in Government and appointment as meritorious sportspersons in PSUs including Applicability of Eligibility Criteria Prescribed for the Posts, Categorisation of Posts under Government / PSUs for different level of Sports Achievements, the posts identified in Government and PSUs with methodology of appointment, criteria for preparation of merit list and other eligible criteria and provisions.
- 5. The Government after careful examination of the recommendations of the High Level Committee, order that:-
 - (a) the sports achievement eligible for quota under the Government and for appointment as meritorious sportspersons in PSUs, the applicability of eligibility criteria prescribed for the post, the posts identified for different levels of sports achievement and the methodology of appointment of the eligible sportspersons shall be as prescribed in the Annexure to this Government Order.
 - (b) 3% Quota will be allotted for eligible sportspersons in the recruitment for the posts identified by Government as given in the Annexure to this Government Order.
 - (c) the criteria for preparing the merit list by the Selection Committee and other criteria relating to appointment of the eligible sportspersons would be as prescribed in the Annexure to this Government Order.
 - (d) suitable amendments will be made to the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 and Fundamental Rules accordingly.

- (e) Public Sector Undertakings (PSUs) are also instructed to adhere to the guidelines and modality for appointment of eligible meritorious sportspersons as given in the Annexure to this Government Order.
- 6. Orders to constitute a Selection Committee for Category-II and Category-III posts as given in the Annexure to this Government Order will be issued separately.

ANNEXURE TO G.O.(Ms) No.6, Youth Welfare and Sports Development (S1) Department, Dated 20.02.2019

Guidelines and modalities regarding 3% quota for meritorious sportspersons in the recruitment for selected posts in Government Departments and provisions for appointment of meritorious sportspersons in PSUs.

1. Sports Achievements Eligible for Sports Quota in Government and appointment as meritorious sportspersons in PSUs.

The medalists and participants of international competitions mentioned below, medalists in National Competitions mentioned below and medalists in State Championships mentioned below will be eligible for sports quota in Government and appointment as meritorious sportspersons in PSUs.

(i) Achievements made in the following International competitions will be eligible:

International Competitions

- (a) Summer Olympic Games,
- (b) Commonwealth Games,
- (c) Asian Games,
- (d) World Championships conducted, either once in 4 years or once in 2 years or annually, by International Sports Federation (ISF) recognised by International Olympic Committee (IOC).
- (e) Commonwealth Championships conducted, either once in 4 years or once in 2 years or annually, under aegis of ISF recognised by IOC.
- (f) Asian Championships conducted, either once in 4 years or once in 2 years or annually under aegis of ISF recognised by IOC.
- (g) South Asian Federation Games (SAF Games).
- (h) Paralympic Games.
- (i) Asian Para Games
- International Blind Sports Association (IBSA) World Games and Deaflympics organised by International Committee of Sports for the Deaf.

- (ii) Among <u>National level competitions</u>, the following competitions will be eligible:
 - (a) National Games,
 - (b) National Championships conducted by National Sports Federations recognised by Ministry of Youth Affairs and Sports.
- (iii) <u>State Championships</u> conducted by State Sports Associations recognised by Sports Development Authority of Tamil Nadu (SDAT).
- (iv) Among all the levels of competitions, **only senior level competitions** are eligible for consideration.
- (v) Among the above mentioned International, National and State level competitions, the sports disciplines which would be eligible for consideration under the sports quota, will be as follows:
 - (a) For multi disciplinary games like Olympics, Asian Games, Commonwealth Games, National Games etc., all sports disciplines included in that games would be eligible.
 - (b) For other International Competitions like World Championships, Commonwealth Championships and Asian Championships, only sports discipline that are part of the last Summer Olympics would be eligible.
 - (c) For National and State level championships, in addition to Summer Olympics sports disciplines the following sports disciplines which are part of the Asian Games would also be eligible.

Roller Skating, Squash, Kabbadi and Wushu.

- (vi) The cut-off date of sports achievement for eligibility to the appointment will be 01.01.2018. Therefore, all the sports achievements made on or after 01.01.2018 will only be considered.
- (vii) Further, after 31st December, 2022, the achievements made during the last 5 years preceding the year of application only are to be considered.

2. Applicability of Eligibility Criteria Prescribed for the Posts:

Applicability of the eligibility criteria which are prescribed for any particular post, to the persons considered under sports quota or for appointment as meritorious sportspersons in PSUs will be as follows:

- (i) The sportspersons should fulfill all the minimum education qualification criteria prescribed for the post;
- (ii) However, the maximum age limit will be relaxed up to 40 years as the sportspersons are mostly engaged in sporting activity till the age of 35 to 38 years.

3. <u>Categorisation of Posts under Government / PSUs for different level of Sports Achievements.</u>

As the level of sports achievement varies widely from a medal in Olympic Games to a medal in State Championship, the posts will be categorised for different level of sports achievements as follows. (For different Championships, only the sports disciplines given at Para 1(v) above will be eligible.):

(i) Category-I (Grade Pay Rs. 5,400 and above as per 6th Pay Commission):

- (a) Medalists of Summer Olympic Games, Paralympic Games and World Championships held once in 4 years.
- (b) Gold Medalists of Commonwealth Games, Asian Games and Asian Para Games.

(ii) Category-II (Grade Pay Rs.4,400 and above but below Rs.5,400 as per 6th Pay Commission):

- (a) Silver or Bronze medalists in Commonwealth Games, Asian Games or Asian Para Games.
- (b) Medalists in the World Championships held once in 2 years or annually.
- (c) Medalists of IBSA (International Blind Sports Federation) World Games and Deaflympics.

- (d) Medalists of Asian Championships or Commonwealth Championships held either once in 4 years or once in 2 years or annually.
- (e) Medalists of SAF Games.
- (f) All participants who have represented India in Summer Olympics or Commonwealth Games or Asian Games or World Championships held once in 4 years.

(iii) Category-III (Grade pay Rs.2,400 and above but below Rs.4,400 as per 6th Pay Commission):

- (a) Participants representing India in World Championships held either once in 2 years or annually.
- (b) Participants representing India in Commonwealth Championships or Asain Championships held either once in 4 years or once in 2 years or annually.
- (c) Participants representing India in SAF Games.
- (d) Medalists in National Games.
- (e) Medalists in National Championships.

(iv) Category-IV (Grade Pay below Rs.2,400 as per 6th Pay Commission barring the Post of Office Assistants):

Medalists in State Championships.

The sportspersons who are eligible for a particular category of posts would also be eligible for category of posts below that category. For example, a sportsperson who is eligible for posts placed in Category - II would also be eligible for posts placed in Category - III and IV.

5. Criteria for Preparing Merit List by the Selection Committee:

The following criteria will be followed for preparation of the merit list by the Selection Committee for the posts coming under its purview:

- (i) Marks will be given based on the level of sports achievement as per marking scheme prescribed below for the best achievement made by the sportspersons during the eligible period.
- (ii) In case, the same marks is obtained by more than one sportsperson on the basis of criterion (i) above, the second best achievement during the eligible period will be considered for deciding the inter-se ranking in the merit list. If the marks obtained on the basis of the second best achievement during the eligible period is also the same, the next best achievement during the eligible period will be considered and so on.
- (iii) If rank of more than one sportsperson is the same after criterion(ii) above, the sportsperson who made the best achievement in earlier financial year, will be given priority.
- (iv) If more than one sportspersons are equal after criterion (iii) above, the sportsperson having earlier date of birth will be given higher inter-se ranking in the merit list.

The sportsperson higher in the merit list will be allotted post having higher scale of pay among the vacancies intimated by Recruiting Body provided he/she fulfils eligibility criteria.


